Pour downwind and allow as little free fall as possible while emptying bags into equipment. Breathing must be protected when large quantities are decanted without local exhaust ventilation.

**Sensitization****Assessment of sensitization:**

Chromate in this product has been reduced. Sensitization due to chromate within stated shelf-life is unlikely.

**Repeated dose toxicity****Assessment of repeated dose toxicity:**

After repeated exposure the prominent effect is local irritation. The product has not been tested. The statement has been derived from the properties of the individual components.

**Genetic toxicity****Assessment of mutagenicity:**
